

12:30 - 2:00 PM, Bishop AB | Breakout 1A: A Communications Crisis in a Rural Community Frin Sullivan, PhD

The stability of rural health care delivery systems may be determined by hospital and clinic administrative and governance leaders' effectiveness in communicating about significant events and strategic decisions to other stakeholders. How do leaders ensure the right messages are communicated to the right audiences at the right times? In this session, we will discuss a Harvard Business School-style case study about a massive communications failure between a hospital board and CEO as an opportunity for participants to analyze common communication challenges and think through how this failure could be prevented. At the end of this session, you will have a foundational understanding of the importance of a crisis communications strategy as part of a broader emergency preparedness plan.

Tom Evans MD, FAAFP, President and CEO at IHC

Tom Evans has been President and CEO of IHC since 2005. Dr. Evans received a bachelor and master of arts degree from Drake University. He received his medical degree from the University of Iowa in 1983 and completed his Family Medicine residency at Broadlawns Medical Center in 1986. He practiced family medicine for thirteen years before serving as chief medical officer for the lowa Health System from 1999 to 2005. Dr. Evans has served as President of both the Iowa Medical Society and the Iowa Academy of Family Physicians. He has also served on the delegations for both the American Medical Association (AMA) and the American Academy of Family Physicians. Dr. Evans is a faculty member with the Institute for Healthcare Improvement, the College of Medicine at Des Moines University and the College of Public Health at the University of Iowa. He also serves on the Board of Trustees for Bethel University in St. Paul, Minnesota.

Jennifer Brockman MHA, BSN, RN, Chief Clinical Program Officer at IHC

As the Chief Clinical Program Officer for IHC, Jennifer Brockman leads an organizational structure that supports quality improvement, patient safety, change management, data analytics and achievement of strategic directives. Brockman has more than twenty years of clinical nursing experience in a variety of healthcare settings including acute and long-term care, quality management and infection prevention. She received a Bachelor of Science and Nursing Degree from the University of Iowa and Master's in Healthcare Administration (MHA) Degree from Walden University. Maulik Joshi, Dr.P.H. is the President and CEO of Meritus Health, Inc. This organization includes the proposed Meritus School of Osteopathic Medicine (MSOM) and Meritus Medical Center (MMC). Previously, Maulik was the COO and executive vice president at the Anne Arundel Health System (AAHS). Prior to AAHS, Maulik was at the American Hospital Association as associate executive vice president and president of the Health Research and Educational Trust. Maulik has also worked at the Institute for Healthcare Improvement, the Agency for Healthcare Research and Quality, the University of Pennsylvania Health System and The HMO Group. Maulik earned his Doctorate in Public Health and MHA from the University of Michigan. He was editor-in-chief for the Journal for Healthcare Quality. He also co-edited The Healthcare Quality Book: Vision, Strategy and Tools (5th edition published in 2022) and coauthored Healthcare Transformation: A Guide for the Hospital Board Member and Leading Healthcare Transformation: A Primer for Clinical Leaders (2nd edition published in 2023). Maulik has authored a combination of over fifty peer-reviewed articles, commentaries and perspectives. Maulik is an adjunct faculty at the University of Michigan School of Public Health in the Department of Health Management and Policy where he teaches annually. He serves on numerous Boards of Trustees within and outside of healthcare.

Jaime Bland, DNP, RN, President and CEO of Regional Health Data Utility - CyncHealth

Since being appointed CEO in 2018, Dr. Bland has piloted CyncHealth's strategic growth beyond the established health information exchange and Prescription Drug Monitoring Program in Nebraska to include four new entities. This includes CyncHealth Advisors, the CyncHealth Foundation, the Nebraska Healthcare Collaborative and CyncHealth Iowa. Dr. Bland serves as an influential and impactful board member for each of these entities as well as a number of regional and national organizations guiding the expansion, use and accessibility of health data. Prior to CyncHealth, Dr. Bland has held leadership positions in regional, national, and international markets within the public and private sectors. Dr. Bland has extensive experience in establishing and leading care management, population health, and clinical quality initiatives. She holds advanced degrees in informatics and a Doctor of Nursing Practice in Public Health-Global Health Nursing from Creighton University in Omaha, Nebraska.

Benjamin Anderson, MBA, MHCDS, President and CEO, Hutchinson Regional Healthcare System

Benjamin Anderson is responsible for the management, direction, and coordination of all organizational operations and related activities in pursuit of the goals and objectives as set forth by the Board of Directors. During the four years prior to joining Hutchinson Regional Healthcare System, Benjamin served as Vice President for Rural Health and Hospitals at the Colorado Hospital Association, where he provided leadership and direction in the development and execution of the Association's rural strategies, advocated on behalf of rural hospitals and health systems and developed strategic partnerships with organizations that affected the health of rural Coloradans. Before his move to Colorado, Benjamin served as CEO of Kearny County Hospital, a comprehensive rural healthcare delivery complex in Lakin, Kan. that serves patients of thirty nationalities within a 180-mile radius. During his time there, he led the organization through a period of rapid growth, expanding access to coordinated primary care and specialty services. Anderson is a recognized leader in transforming rural health care through a mission-driven approach to recruiting physicians to underserved areas, tying together domestic and international service. His work was recognized on CBS Sunday Morning, NPR, and in POLITICO and Sports Illustrated. Anderson was named to Becker's Hospital Review's Rising Star list of healthcare leaders under 40 and one of Modern Healthcare's 2014 Up and Comers. He earned a Bachelor of Arts in English in 2004 and Master of Business Administration in 2007 from Drury University. He also obtained his Master of Healthcare Delivery Science in 2016 from the Tuck School of Business at Dartmouth College.

Shawna Forst, CPHQ, MBA, Performance Excellence, Quality and Risk Coordinator, MercyOne Newton Medical Center

Shawna Forst leads the Patient and Family Advisory Council at her organization. Shawna graduated from Simpson College in 2002 with a Bachelor of Arts in Physical Education and a Coaching Endorsement. In 2010, she became a CPHQ and received her Lean Green Belt certification in 2014. In 2018, Shawna earned her Masters in Business Administration from Western Governors University. She has certifications in Nonviolent Crisis Intervention, A.L.I.C.E. (active shooter response) and Hospital Emergency Coordinator through Georgia Regents University, Shawna currently serves on the Board for the Iowa Association for Healthcare Quality and has been a member of the National Association for Healthcare Quality since 2010. In 2010, she co-authored Lean Healthcare in Action: A practical Guide to Streamlining Processes. Shawna has a passion for supporting healthcare colleagues in all areas of quality to help provide safe and quality care to patients. She strives to help elevate and center the patient voice.

Jayson Henry, CEO, The Well Offering Help and Hope

Jayson Henry is the CEO of The Well, a 501(c)(3) organization impacting the lives of people struggling in poverty, with locations currently in four lowa communities. The Well collaborates with other local partners interested in more effectively supporting people who lack stability in life. Their unique approach to breaking dependencies and putting people on a path to transformation is receiving recognition across the state of lowa and beyond, attracting visits from the lowa governor and other state and local representatives.

Taking a seemingly traditional path after high school, Jayson attended Iowa State University to study business management. Upon graduation in 1994, he accepted a position at Pella Corporation in Pella, Iowa to pursue a job in business where he held various manufacturing leadership roles. In 2011, he joined Vermeer Corporation in Pella, leading manufacturing operations, while concepting with a group of community members what would soon become The Well. Unbeknownst to his peers, he had spent his adult life trying to escape the hurtful and often tumultuous childhood that he knew growing up, one of generational poverty. Jayson was elected as the first chair of The Well Board of Directors in 2014 and appointed CEO in 2015 where he has led The Well in double digit growth annually, increasing their ability to impact the lives of people struggling in poverty.

Erin E. Sullivan, PhD, Associate Professor of Healthcare Management, Sawyer School of Business at Suffolk University

Erin Sullivan is a scientific storyteller in a discipline dominated by quantitative measures. She illuminates quantitative findings with rigorous thematic, inductive and deductive analyses of the stories of the human beings who comprise small and large datasets, thus providing texture and meaning to the numbers that healthcare and medicine favor but which fail to provide the context for the findings.

She conducts research that raises the status and importance of primary care in the United States health system, focusing on understanding the mechanisms that support excellent and sustainable primary care practice in the United States. Her applied research bridges management principles and primary care in ways that strive to improve the efficacy of care delivery and performance of primary care practices. In the last five years, she has conducted primary care focused research related to three critically important topics: 1) Burnout mechanisms, reduction and elimination 2) The lessons from the devastating impact of COVID-19 on healthcare providers and 3) The role of physician leadership in more effectively guiding healthcare systems. Professor Sullivan's research is published in top journals such as the Journal of General Internal Medicine, the Journal of the American Board of Family Medicine, the New England Journal of Medicine Catalyst Innovations in Care Delivery and the Journal of Healthcare Management.

Sullivan teaches leadership and organizational change as well as the capstone course to students in the MHA program. She has extensive experience in the areas of case-based teaching and experiential learning. In addition to her teaching and research, Professor Sullivan serves on the editorial boards of the Case Research Journal and the Journal of Healthcare Administration Education. She also currently holds a faculty appointment in the Department of Global Health and Social Medicine/Center for Primary Care at Harvard Medical School. Professor Sullivan has conducted research related to healthcare delivery in over ten countries and on three continents. She holds a Bachelor of Arts in Art History from Wellesley College and a PhD in Business Studies from Trinity College, Dublin.

Julia Pyle MSN, RN, Quality Improvement Advisor, Kansas Healthcare Collaborative (KHC)

Julia Pyle joined KHC in April 2022 as a Quality Improvement Advisor. She provides consultation and quality improvement support to hospitals and other healthcare organizations across the state collaborating with KHC in quality and patient safety initiatives. Through coaching, technical assistance, and engaging with healthcare leaders, Julia provides support for improvement related to safe patient care. In her role, she draws on continuous improvement methodologies and operational/clinical expertise to analyze and influence improvement using evidence-based practices. Julia brings more than thirty years of progressive experience in the healthcare industry with a background that includes critical care, education, supervisory and executive leadership roles.
