Privacy Policy

Ihconline is committed to protecting your privacy and developing technology that gives you the most powerful and safe online experience. This Statement of Privacy applies to the Ihconline Web site and governs data collection and usage. By using the Ihconline website, you consent to the data practices described in this statement.

Collection of your Personal Information

Ihconline does not collect personal information.

There is also information about your computer hardware and software that is automatically collected by Ihconline. This information can include: your IP address, browser type, domain names, access times and referring Web site addresses. This information is used by Ihconline for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the Ihconline Web site.

Ihconline keeps track of the Web sites and pages our customers visit within Ihconline, in order to determine which Ihconline services are the most popular. This data is used to deliver customized content and advertising within Ihconline to customers whose behavior indicates they are interested in a particular subject area.
